CCB REFUND POLICY

Refunds of registration fees, excluding late fees unless otherwise specified, will be issued in accordance with the following guidelines:
A. Medical Refund. A full refund, including any late fee, will be issued if a player is unable to participate for medical reasons for the whole season. In case the refund is requested during the season the CCB refund committee will decide the amount of refund amount the player is eligible for. To qualify for a medical refund, a note from a physician stating that the player should not participate in soccer must be submitted with the refund request.
B. Placement Failure Refund. A full refund, including any late fee, will be issued if the Club is unable to place the player on a team. Placement Failure Refunds result when a player is unable to participate in Club sponsored soccer due to a lack of available space.
C. Withdrawal Refund. Withdrawal Refunds must be requested before **April 15, 2018**, inclusive and a refund of the registration fee less a \$50 administrative fee will be issued.
 The refund request will only be met if none of the following terms and conditions are met:
 1. Refund request is past the deadline.
 2. Player has already been placed on a select team.
 3. Refund request is missing information as requested.

REFUND REQUESTS RECEIVED AFTER JULY 31st WILL NOT BE HONORED UNDER ANY CIRCUMSTANCE.

CODE OF CONDUCT FOR PLAYERS:
 All players must respect any/all decisions made by any match official. CCB has a zero tolerance policy for disrespect of referees, field marshals etc.
 All players must respect coaching staff and management team of CCB and any opposing team. Zero tolerance on any sort of disrespect and/or verbal or physical abuse.
 All players wanting to play at select levels must be present at the tryouts and shall be willing to play on the team that the technical directors and the coaches deem appropriate for their skill set.
 All players must be registered in their proper age group prior to use any practice or match facilities provided by CCB.
 All players must respect all fellow players either on their team or opposing teams.
 All players must show up to practices/games scheduled by their coaching staff unless they have acquired prior permission to miss the event.
 All players must notify the coaching staff of any/all injuries so that the coaching staff can make an appropriate decision in respect with the players use on field.
 All players must play with the spirit of sportsmanship.
 All players must only play in the gear assigned to them by CCB.

CODE OF CONDUCT FOR PARENTS:
 To ensure that all mini/youth players come to the fields in proper soccer gear.
 To positively encourage all players on the field.
 To have a respectful behavior towards all other parents including the parents from the opposing team.
 To inform the coaching staff about any/all injuries the player might have.
 To have total respect for the coaching staff and the management team at CCB.
 All parents should respect all match officials.
 CCB TECHNICAL COMMITTEE HOLDS THE RIGHT TO PLACE PLAYERS ON ANY TEAM BASED ON THEIR ABILITY AND SPACE AVAILABLE.

Release and Waiver

Release and Waiver of Liability, Assumption of Risk and Indemnity and Parental Consent Agreement ("agreement")

IN CONSIDERATION of being permitted to participate in any way in CENTRAL CITY FOOTBALL CLUB Activities ("Activity") I, for myself for personal representatives, assigns, heirs, and next of kin:

ACKNOWLEDGE, agree, and represent that I understand the nature of CENTRAL CITY FOOTBALL CLUB Activities and that I am qualified, in good health, and in proper physical condition to participate in such activity. I further agree and warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue further participation in the Activity.

FULLY UNDERSTAND THAT: (a) CENTRAL CITY FOOTBALL CLUB ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS, AND DEATH ("RISKS"); (b) these Risks and dangers may be caused by my own actions or inaction's, the actions or inaction's of others participating in the Activity, the condition in which the Activity takes place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISK AND SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I incur as a result of my participation or that of the minor in the Activity.

HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE CENTRAL CITY FOOTBALL CLUB AND ITS AFFILIATES, their respective administrators, directors, agents, officers, members, volunteers, and employees, any sponsors, advertisers, and, if applicable, owner and lessors of premises on which the Activity takes place, (each considered one of the "RELEASEES" herein) FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY ACCOUNT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE "RELEASEES" OR OTHERWISE, INCLUDING NEGLIGENT RESCUE OPERATIONS AND I FURTHER AGREE that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT I, or anyone on my behalf, makes a claim against any of the Releases, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which may incur as the result of such claim.
